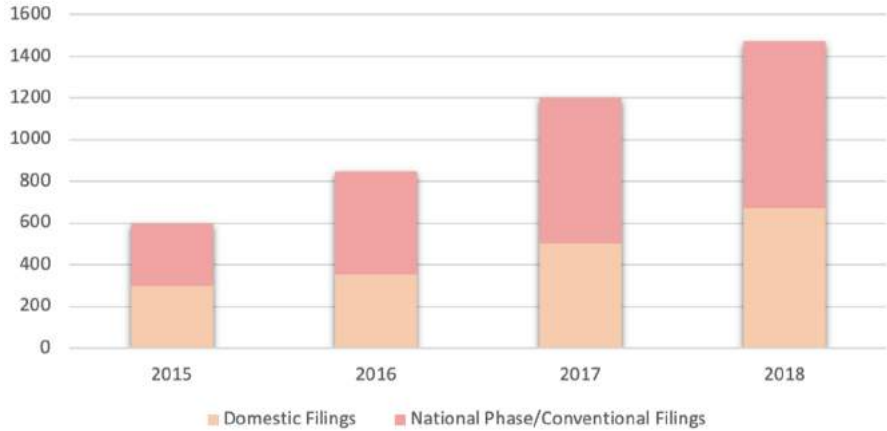

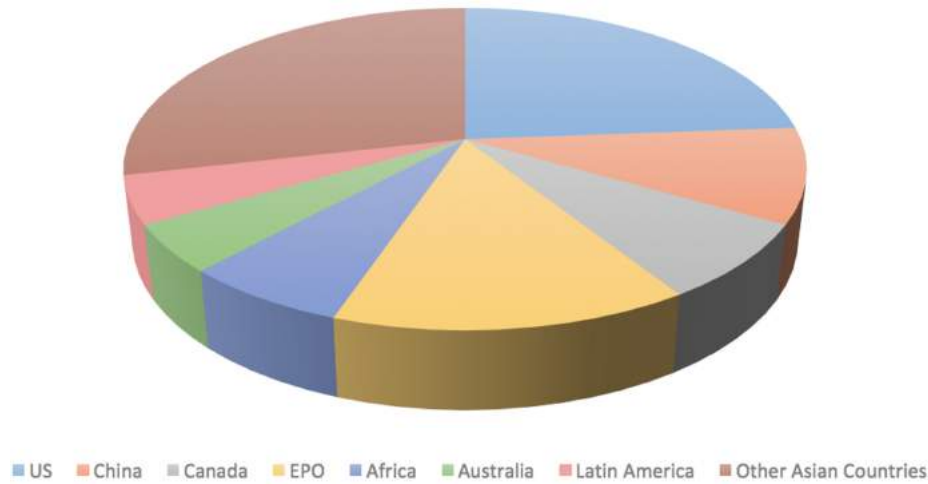

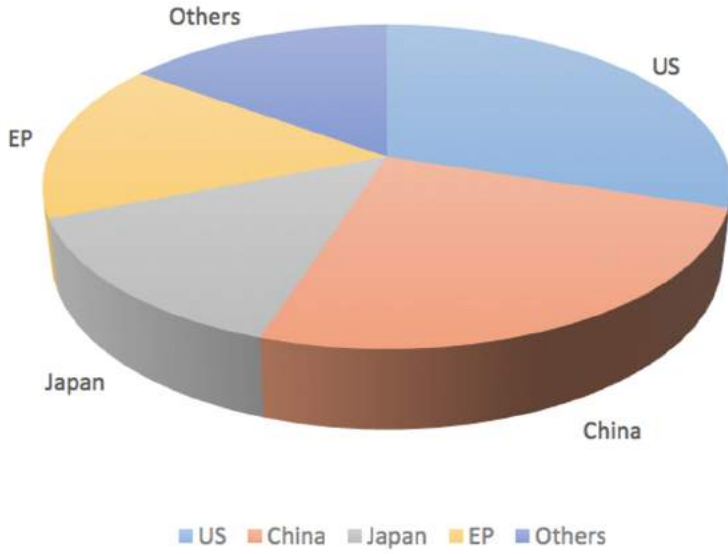
## Patent Filing Trend In Last 4 Years



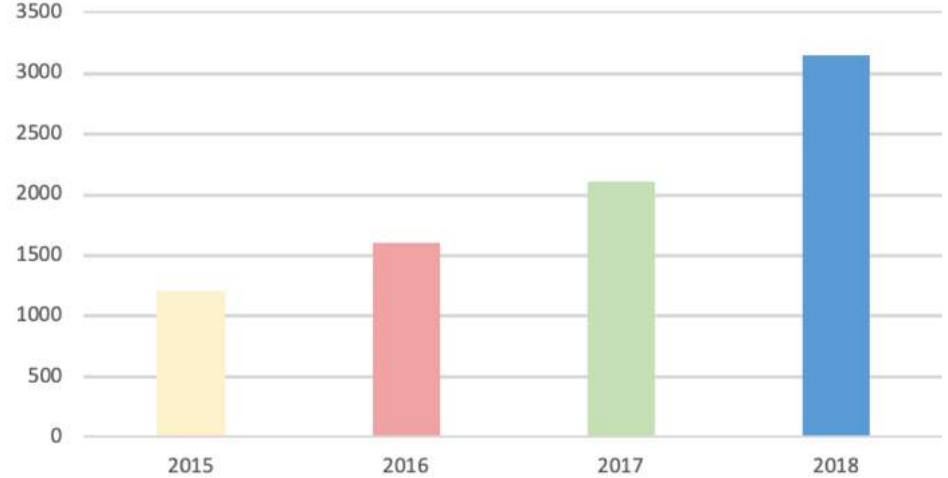
## Country Level Filing Split



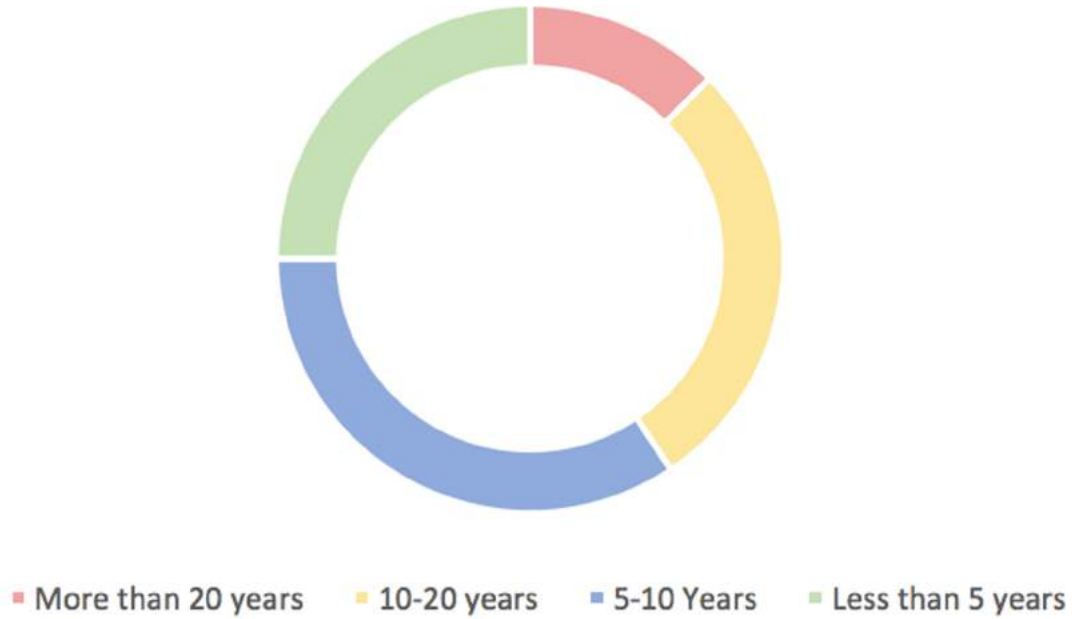
## Geographical Split Of Client Base



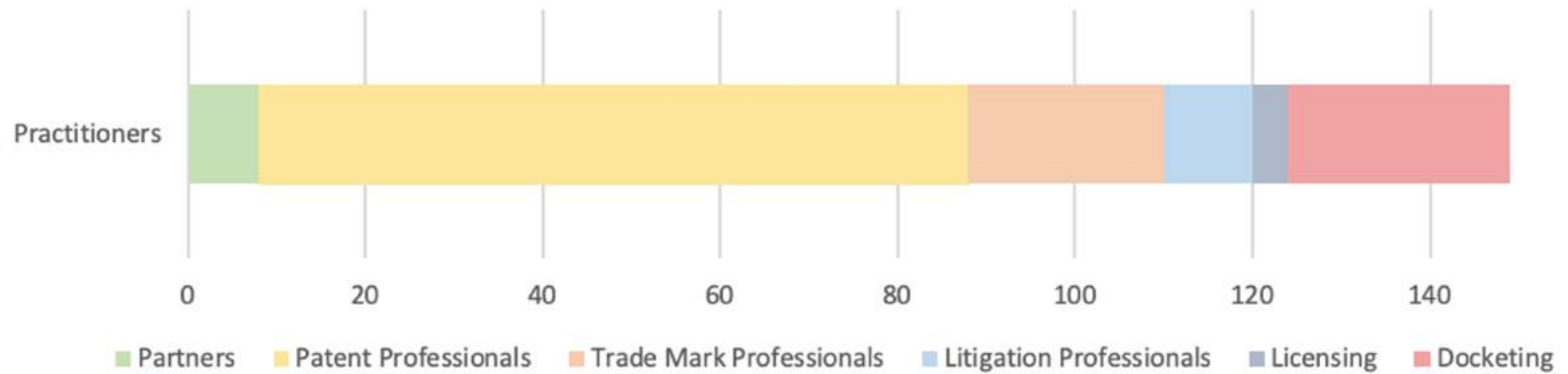
## Trademark Filing Trend In Last 4 Years
